Seeking A Court Ordered Title

Hello,

If you have received this packet, we have not been able to issue a title through the standard procedures with the Clerk of Court's Auto Title Division. There is a process established to obtain a title when this happens. While the Clerk of Court's is unable to issue a title based on the information provided, the Common Pleas Court, General Division has the ability to issue you a Court Ordered title.

Attached is a blank "Petition for Court Ordered Certificate of Title" along with a statement of fact. It is very important that you complete both documents with as much detail as you can. The packet is the basis on which the court will determine if they can issue a Court Ordered Title. As a reference, there is never too much information available to assist with the decision.

After the forms are completed, you must bring them to the Clerk of Courts Legal Division located at 41 N. Perry Street, Room 104, Dayton, Ohio. The Deputy Clerk will file the Petition and create a civil case seeking a Court Ordered title. There is an initial deposit of \$334.75 due at that time of filing. This money will be on deposit. The Clerk's Office will issue a refund for the unused funds at the conclusion of the case.

The Court may or may not determine if a hearing is necessary. Any communication regarding hearing proceedings will come from the Court. We realize the Court process may be intimidating; we hope this packet helps you get through the process easier.
